

AN ORDINANCE RE-NAMING THE STREETS IN THE VILLAGE OF MOOSE LAKE,
MINNESOTA

WHEREAS, The Village council of the Village of Moose Lake, Minnesota considers it advisable for the purpose of promoting public convenience and general welfare, that the streets and avenues in the Village of Moose Lake, Minnesota, be named or re-named, as the case may be, and

WHEREAS, The Village Council of the Village of Moose Lake, Minnesota has thoroughly studied the matter of such naming and re-naming, & has deemed it advisable to name and re-name the streets and avenues as hereinafter set out.

The Village Council of the Village of Moose Lake, Minnesota, do ordain as follows:

Section 1. The designated numbered streets in the Village of Moose Lake, Minnesota, running in an east and west direction and being designated as First Street to Eighth Street, inclusive, shall remain as numbered theretofore on the Plats heretofore filed with the Register of Deeds of Carlton County, Minnesota.

Section 2. The Following streets and avenues in the Village of Moose Lake, Minnesota, shall be named or re-named as the case may be, as follows:

a) Avenue H. shall be re-named Ash Avenue, and shall be hereafter known and designated as Ash Avenue.

b) Avenue G shall be re-named Birch Avenue, and shall be hereafter known and designated as Birch Avenue.

c) Avenue F shall be re-named Cedar Avenue, and shall be hereafter known and designated as Cedar Avenue.

d) Avenue E shall be re-named Douglas Avenue, and shall be hereafter known and designated as Douglas Avenue.

e) Avenue D shall be re-named Elm Avenue, and shall be hereafter known and designated as Elm Avenue.

- f) Avenue C shall be re-named Fir Avenue, and shall be hereafter known and designated as Fir Avenue
- g) Avenue B shall be re-named Grove Avenue, and shall be hereafter known and designated as Grove Avenue.
- h) Avenue A shall be re-named Hickory Avenue, and shall be hereafter known and designated as Hickory Avenue.
- i) The Avenue extending north from State Highway # 73 , or West Road, as that portion of Highway # 73 lying within the Village of Moose Lake, shall be hereafter designated, between the present Sidney G. Lee property and the George Peterson property, the southeasterly corner of said Avenue being at the point of intersection of the north edge of said Highway # 73, and a line drawn at right angles to said north edge of said Highway # 73, and eighty-five (85) feet west of the westerly or northwesterly right of way line of the Minneapolis, St Paul & Ste. Marie Railway Co., as the same runs through the Village of Moose Lake, and over and across the SW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 20, Township 46, Range 19, Carlton County, Minnesota and being an Avenue 50 feet in width, shall be Ironwood Avenue, and shall be hereafter known and designated as Ironwood Avenue.
- j) That portion of State Highway # 73 and # 27, extending through the Village of Moose Lake, from its intersection or junction with Highway # 61 in the Village of Moose Lake, and extending West to the Village limits, shall be named West Road, and shall hereafter be known and designated as West Road.
- k) That Avenue which abuts and bounds the westerly edge of the present Village limits of the Village of Moose Lake, and runs north from the Railroad right of way of the Minneapolis, St Paul & Sault Ste, Marie Railway Company, as said right of way runs acrosss the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 20, Township 46, Range 19, in Carlton County, Minnesota, shall be named Kenwood Avenue and shall be hereafter known and designated as Kenwood Avenue.

l) That street or road extending from the intersection of First Street and Avenue D (now Elm Avenue) and extending in a southwesterly direction along the Lake Shore of Moose Head Lake, extending over and Across the plat of Lakeside Addition to the Village of Moose Lake, and thence angling in a southerly and southwesterly direction over a portion of Auditor's Sub-division #24, over a portion of the SW $\frac{1}{4}$ and NE $\frac{1}{4}$ of Section 29, Township 46, Range 19, and over and across Government lot 4 in said Section 29, and past the Moose Lake State Hospital to the south edge of the Village Limits in said Government Lot 4, shall be named Lakeshore Drive, and shall hereafter be known and designated as Lakeshore Drive.

m) That street or road extending along the westerly or northwesterly side of and abutting the Northern Pacific Railroad right of way, as the same extends through the Village of Moose Lake, in a southwesterly - northwesterly direction, shall be named Industrial Road, and shall be hereafter known and designated as Industrial Road.

n) That part of U. S. highway # 61, as the same extends through the Village of Moose Lake, from the northerly or northwesterly edge of the Village limits, shall be named Arrowhead Lane, and shall hereafter be known and designated as Arrowhead Lane.

Section 3. If any of the provisions of this ordinance and the application thereof to any person or circumstances is held invalid, such invalidity shall not affect ather provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

Section 4. This ordinance shall take effect and be in force from and after its passage and publication.
